- Applications received after June 15th will be considered upon available space.

Acceptance: Will be a rolling basis to be wrapped up on June 22nd.

- \$85 Booth Fee (will be processed upon acceptance)

Load-in/Set-up: Sunday, July 15th 7:00 am – 9:00 am

Show Hours: Sunday, July 15th 10:00 am – 5:00 pm *Rain or Shine*

Booth Pricing & Inclusions:

Booth Pricing:

- \$15 Registration and Jury fee. (Non-Refundable)
- \$85 Booth Fee (checks payable to Zorvino Vineyards) due with application and cashed upon acceptance.
- Note that we will charge a \$35 fee each time a check is returned by your bank.
- No refunds.
- Artists are required to supply their own 10 x 10 tent and protective cover and to be prepared for inclement weather as the art show continues rain or shine.

Booth Inclusions:

- Complimentary Parking on-site
- Mention in print advertisements, email marketing & social media campaigns.

Fine Art Show Criteria:

- All artwork must be by the artist, original and framed or otherwise ready to hang or display.
- Zorvino Vineyards reserves the right to refuse any artwork that does not meet these qualifications.
- Booths should be attended to at all times and are expected to be open during the entire art show.

Rules:

- Exhibitors will not be allowed to nail, screw or attach anything to columns, trees, doors, etc.
- All displays must look professional, clean and safe for customers.
- All trash must be placed in the trash receptacles provided.
- No outside alcoholic beverages will be permitted on Zorvino Vineyards property.
- No dogs allowed on premises.
- Exhibitors must be open during show hours – packing up and/or leaving early is prohibited.
- Zorvino Vineyards reserves the right to remove anyone not complying with these rules.
