ENTRY FEE: \$25.00. Up to 3 entries, (2 views each of 3 entries for SCULPTURE ONLY)

PRIZE: \$200.00 in prizes will be awarded at the reception.

Unsold work picked up:	By Jan 3, 2021

ENTRY PROCEDURE: Artists may submit up to three entries (two views each for sculpture only). This is the link to apply online <http://www.lowellartshows.com/brushmember/>

A \$25 non-refundable payment made to the Brush Art Gallery is required with entries. You will receive an e-mailed confirmation and invoice. Either mail a check or pay online [ENTRY FEE](#).

- All media is accepted
- Work must be no larger than 72" high and 48" wide
- Sculptures may not be heavier than 30 pounds
- Please submit up to three jpegs on-line. The total number of jpegs for sculpture is six, including a different view for each work
- Fill in the on-line application form below and click on the SUBMIT button.
- After submitting the on-line form, you will be e-mailed an invoice and asked to pay the entry fee in one of two ways:
 - A. PayPal -OR-
 - B. Personal Check
- **** Just follow the instructions of the e-mailed form.*
- Delivery of Work: You must hand-deliver your accepted work
- **Note: all communication, including jury decision will be done via e-mail, so make sure to provide an e-mail address that you check frequently.**
